

INSPECTION REPORT

Name of the school:

BHAVAN'S VIDYA MANDIR,
KOLAYAKKAD,
MANNAPRA P.O,

The school was visited on 23/12/2011 at 11.30am by the undersigned, District Education Officer, Palakkad . The inspection was conducted as per guidelines laid down in GO (MS) No-202/11/G.Edn dated 7.10.2011.

1. The school is set up by Bharatiya Vidya Bhavan, Mumbai. Bharatiya Vidya Bhavan, Mumbai, is a society registered under Societies Registration Act, 1860. The Society is also registered as a public trust under the Bombay Public Trusts Act, 1950. The relevant documents have been verified. Bharatiya Vidya Bhavan, Mumbai, has purchased a plot measuring about 11.28 acres for the exclusive use of the school, Bhavans Vidya Mandir, Kolayakkad, Mannapra Post, Palakkad District. Assignment deeds relating to the property have been verified and notarised copies of the 3 assignment deeds and the latest basic tax receipt are enclosed with this report. Possession certificate, location certificate and location sketch issued by Village Officer, Kannambra II, have been verified by me and copies are enclosed.
2. The school is managed by a properly constituted governing body as evidenced by the affidavit executed before the Judicial First Class Magistrate (ii) PKD an 08.04.2008. Total number of executive committee are 11 headed by Sri.R.S. Narasimhan, Chairman.
3. The financial statements for the year ended 31st March 2011 was verified by me and I report that the trust has financial stability.
4. The trust has provided 11.28 acres of land for the school with a RCC building for the conduct of classes. It is fully furnished with a science lab, Maths lab and the classes are conducted through E-learning process (smart classes).
5. The school has adequate equipments and furniture.
6. The medium of instruction is English. Malayalam is also taught in the school as a compulsory subject.
7. The rate of tuition and other fee charged is commensurate with the facilities provided.

8. The teachers and staff appointed in the school have requisite qualification and are paid salary as per the norms laid down by the Government of Kerala. All are covered under EPF and the subscriptions of PF are remitted regularly. There are 22 teachers including principal of which principal and five others are post graduates and trained. The management has appointed five more teachers from 01.06.2011 onwards.
9. The school has satisfied the pupil - teacher ratio of 30:1.
10. The admission to school is open to all without any discrimination.
11. No unrecognised class/branches are run in the premises or in the same name of the school.
12. The school was set up on 7th October 2000 and thus is in existence for the last 11 years.
13. All the children have been enrolled under UID.
14. The school has adequate number of toilets. Separate toilets for girls are provided.
15. Potable drinking water is provided in the school.
16. A total station survey plan with the school building marked therein was produced for my verification.
17. Suitable equipments, furniture, lab equipments, sports equipments are available at the school. There are 3183 books in the library. There is a full-fledged computer lab in the school. 20 Computers are installed.
18. The Chairman, Bharatiya Vidya Bhavan Puthucode Kendra has executed a declaration to the effect that the office and records shall be open for inspection to the Board/State Education Department and the rate of tuition and other fees charged shall be commensurate with the facilities provided and admission to the school shall be open to all without any discrimination and that no unrecognised class/branches will be run within the premises of the school or in the name of school.
19. Details of Building: The trust/society has provided an RCC building with a ground floor and first floor. Total 18 class rooms, one principal room, one office room, 3 labs, 1 library, 1 sports rooms and 1 art and culture room. There are 24 lavatories and 34 urinals. There are drinking water facilities. Fire extinguishers are provided.

The Hon'ble high court of Kerala in its order No. WP (C) 31426/08 dated 08-04-2009 filed by Bhavans Vidya Mandir, Kolayakkad, Mannapra ordered that order in the common judgement in WP (C) 34912/07 will govern in the writ petition also [WP(C)34184/07 filed by Bharathiya Vidya Bhavan Thriprayar Kendra]. The Hon'ble Supreme Court as per order in SLP 11666-11667/09 vacated the interim stay of the order of the Hon'able Highcourt. Thus this school is also included in the case. The DPI as per letter number NS2/25259/11/DPI dated 13.05.2011 issued notice to the manager to attend the meeting on 21.05.2011 at Rama Nilayam, Thrissur. In pursuance of the notice and the application filed by the school, an inspection was conducted on 02-06-2011 by a team comprising of the officials from the office of Deputy Director, Education, Palakkad. I have considered the report submitted by the inspecting officials and I concur with the findings recorded therein.

As the school has been provided with 11.28 acres of land with a permanent building therein and has satisfied the norms laid down by the Government of Kerala in G.O. (MS) 202/11/G.Edn dated 7th October 2011, I report that the school **Bhavans Vidya Mandir, Kolayakkad, Mannapra Post, Palakkad District** is eligible for grant of NOC for affiliation with Central Board of Secondary Education.
